## GREAT CRANSLEY VILLAGE SHOW 2020

Very sadly with the Virus still providing a considerable risk to people's health, we were unable to hold our Village Show at our Village Hall this year. It was to have been on the 5<sup>th</sup> September, and would have been the 75<sup>th</sup> Cransley Annual show of Flowers, Fruit, Vegetables, Eggs, Cakes, Jams, Photography and Crafts - all produced in our small Community.

It is "typical" that this year has been a very productive year in the Garden, and those of us with fruit trees will be having bumper crops. Also typically my Dalias have been a record size, and I think I would have been a contender for the Trophy this year!!! ... see Photo. My sunflowers were eaten by a Muntjac, so I certainly would not have won that, but look forward to seeing who does.



Out of interest, before we had our own show (Founded in 1945) there was a "Broughton and Cransley Flower and Bird Show" that was started in 1887 to commemorate the Golden Jubilee of Queen Victoria. The first show was held in the Rectory Gardens at Broughton and had Classes for Adults, Cottagers and Juveniles, with entertainment by the Broughton Brass Band. The show was then staged in 1888 in the grounds of Cransley Hall, and moved on alternate years between the Villages. There were, in those days, classes for Exotic Birds, and many people kept Canaries and other foreign Birds. This show continued up to the First World War, and was not revived until 1945.

We are determined that there will be a Show next year, and the date for your Diary is Saturday 4<sup>th</sup> September 2021.

## **NORTH NORTHANTS UNITARY AUTHORITY**

In April 2021, Kettering Borough Council together with 6 other County Boroughs, District Councils and Northamptonshire County Council, will be abolished and replaced by a single new authority to be known as The North Northants Unitary Authority, which will then be responsible for our Village. If you are of voting age, you will be invited to vote for three Councillors to represent your views.

There will still be a Great Cransley Parish Council, and the election to this will be at the same time.

There is currently a 'Shadow' Unitary Authority and we (The Parish Council) are trying to discover if there is any intention to offload the provision of services from the new Unitary Authority to Parish Councils. The current claim is that there is no intention of "Forcing" Parish Councils to be responsible for mowing and maintaining verges and greens, or maintaining street lights, to name just 2 services. However, if the Unitary Authority decides it does not wish to do these things any longer and the Parish Council does not take it up, then who will do it? Answer; No One ... When the street lights go out they will remain out.

We (The Parish Council) have been advised to make a list of all the services our Village currently relies upon, and who is responsible for their maintenance and replacement when necessary. Then we are advised to make investigation into what it would cost for us to do these things ourselves, so that we are prepared for all eventualities.

All householders in the parish currently pay annual Council Tax to pay for these services, at present to the County or Borough. I expect you will think "well, surely they will charge less Council Tax when they no longer have to provide these services?!". I can assure you this will not happen and therefore, when and if, we are in effect forced to take on the provision of whatever the Unitary decide no longer to provide, the only way Great Cransley Parish Council will be able pay for them, will be by increasing our own Precept to cover the costs, and then you will be, in effect, asked to pay for them twice. This has already happened when Kettering Borough went from giving an annual grant to Parishes to forcing us to raise our own Precept each year, there was no reduction in the Borough precept that year, we all had to pay twice.

Please do get interested in this, as it is something that we all have to pay ... we cannot opt out. We should all strive to make sure our elected representatives know our views and then when the time comes vote accordingly.

## **THE THREE CRANES NEWS**

No doubt you will be aware our Village Pub, The Three Cranes, is closed and on the market through Musto Estate agents. The current owner of the Freehold is Pytchley Estates Ltd, which is owned by Mr Barrie Tilley, who purchased the property in March 2018.

Mr Tilley has achieved planning consent to divide the property into two parts - the new building as a separate residential unit, and the Old Pub building which is still registered as a Public House and at present this status cannot be altered without planning consent for change of use.

Cransley residents will recall that following the Public meeting in the Village Hall 18 months ago, the "Action Group" resolved to apply to Kettering Borough Council for an "Asset of Community Value" order, and this was granted on 10<sup>th</sup> January 2019. This order means that the property could not be sold without the Action Group being informed and given the opportunity to come up with an alternative bid to preserve the property as a community asset.

At the beginning of 2020 the Action Group was given the option of making a bid for the site, and declined to do so. This means that at present Mr Tilley can sell without further reference to the group until June 2021, when once again if the property remains unsold the Action Group has to be given the option to purchase.

At all times Pytchley Estates has the right to refuse any offer and they are free to make whatever planning applications re the site they choose. The Action Group and the Parish Council are free to react to any such applications and make their views known to the Planning Authority.

The dilemma that we face at present, is that we all want to see the Pub re-opened, but to achieve this we either need someone to buy it with the intention of reopening, or we need a concerned resident or a group of people to get together and come up with a scheme of running it as a Community Asset. This means not just a Pub, but possibly pop up Post Office, Café, Hair Dressers, Shop, Internet Café, Nail Bar, in fact, any use that will generate income to support the obvious costs of owning and operating a successful enterprise in the Village. The research and time involved in such a scheme would be time consuming and needs dedication and long term commitment, all at an uncertain time, with the Virus threat and imminent Brexit and in the knowledge of the decline of Village Pubs generally over the last 10 years.

Mr. Tilley had offered to allow the group 6 months rent free, to either run the Pub, or try different schemes of operation. This week he contacted the Parish Council to say that no one from the Village had contacted him, or made any proposal known to him, so he was going to take the silence, as a lack of enthusiasm or interest in participating in discussions re the Pub's future.

My personal view is the same as it was in January 2019 in that if we as a Village wish to preserve the Pub there is no point in just talking about it ... it needs a strong, active group, willing to selflessly put in the long term time and effort and fund raising on behalf of the Parish for no reward, and probably considerable grief, especially in the current uncertain times.

I may be incorrect, and forgive me for being deliberately controversial, but I don't believe that such a person or group of people exists in our Village. I hope they will prove me wrong.

Alternatively we can pray for someone to come forward and buy the site with the desire to provide us with a Pub?

If neither of the above occurs, then The Three Cranes will not reopen and the site will be zoned as residential.
